City of Peterborough Social Services

Delivers the Ontario Works (OW) Program to eligible clients including basic needs, shelter costs, basic dental and vision care for children, and prescription drugs, covered under the Ontario Drug Formulary.

Clients may be eligible for Special Diet Allowances and costs towards medical travel and transportation. For the Special Diet Allowance a Physician, Nurse Practitioner, Dietician, or a midwife (if a woman needs a special diet because she is pregnant or breastfeeding) must complete a Special Diet Allowance Application form.

Also delivers the Discretionary Benefits Program for OW and ODSP clients. Discretionary Benefits items and services provided in Peterborough include adult dental and vision care (Ontario Works adults only) dentures, hearing aids, and subsidized transit passes for adults.

Recreation Subsidy: Families who receive ODSP or OW can obtain \$100 per child per year for children for recreational or sports activities. The City of Peterborough also administers a recreation subsidy for low income families and the Jump Start program. A total of up to \$200 can be available. Social Services also administers a municipal Housing Stability Fund – for OW or ODSP clients to help with rent or utility arrears, last month's rent and some costs related to establishing a new residence. An eligibility assessment is required.

Case Managers also provide employment counselling, as well as outreach to County locations and three Emergency Shelters.

Peterborough Children's Services

Children's Services administers a Child Care Fee Subsidy Program for eligible families in Peterborough City and County. This provides full or partial coverage of child care fees for low income families and children with special needs. Also provides subsidies for families returning to school, participating in community or work-related placements, entering the workforce, or social needs placements.

Ontario Disability Support Program (ODSP) – Local Office

ODSP provides income and employment supports to people who have a substantial physical or mental impairment that is documented by a health professional. Other benefits include: prescription drugs covered under the Ontario Drug Formulary, basic dental services, eyeglasses, hearing aids and special

medical necessities. A financial assessment will be made to assess eligibility. Clients may be eligible for Special Diet Allowances and costs towards medical travel and transportation. For the Special Diet Allowance a Physician, Nurse Practitioner, Dietician or midwife (if a woman needs a special diet because she is pregnant or breastfeeding) must complete a Special Diet Allowance Application form.

Housing Resource Centre (HRC)

The Housing Resource Centre helps low income people find and keep housing and prevents homelessness. This includes vacancy listings, and financial assistance for needs such as overdue rent or utility bills. All services are free and available to people of all ages.

The HRC also administers the Housing Stability Fund for low income people not receiving social assistance (OW and ODSP access through Social Services), as well as energy assistance funds for low income households.

Dental Services

No-cost dental services are available for families who are receiving Ontario Disability Support Program (ODSP) or Ontario Works (OW) benefits.

The Healthy Smiles Ontario (HSO) program also provides no-cost dental services for children and youth, 17 or under, without dental insurance, living in households with an adjusted family net income of \$21,683or less (this amount increases by approximately \$1,628.00 for each additional dependent child).

The Children in Need of Treatment (CINOT) program provides dental services for children and youth up to the age of 17, who have an urgent dental condition identified during school oral health screening, or at Health Unit Community Dental Health Centres.

Adults living in Peterborough City or County without dental insurance who are experiencing a dental emergency may be eligible for limited assistance through charitable funds (when available).

Eligible clients are able to access dental services through the dental office of their choice – the Peterborough County-City Health Unit provides dental services at their *Community Dental Health Centre* located downtown at 360 George Street, and on their *Mobile Dental Health Centre* (a fully-equipped, fully-accessible mobile vehicle that travels across the City and County delivering dental services such as check-ups, cleaning, fluoride treatments, fillings, and more).

Canada Revenue Agency – Disability Tax Credit

The disability tax credit (DTC) is a non-refundable tax credit used to reduce income tax payable on the income tax and benefit return. A person with a severe and prolonged impairment in physical or mental functions may claim the disability amount once they are eligible for the DTC.
