Tuberculosis and Diabetes

In Ontario, the prevalence of diabetes has been steadily increasing in recent years. Diabetes increases a person's risk of progression from latent tuberculosis infection (LTBI) to active disease by about three times compared to those without diabetes. Ontario healthcare providers should be encouraged to assess a diabetic person's potential risk for LTBI, assessing them on an individualized basis.

The Canadian Tuberculosis Standards (7th edition) states LTBI screening and treatment should be considered for individuals under the age of 65, who are a part of a population with an increased prevalence of LTBI.

Ontario is similar to other provinces in the overall percentage of LTBI cases with diabetes. However, the percentage of TB cases with diabetes is higher in those born outside of Canada, and those born in Canada who identify as Registered Status Indians, or other Aboriginals, in comparison to non-Aboriginal people born in Canada.

Limited Supply of DTaP-IPV

The Ontario Government Pharmacy has advised health units that they have been seeing a significant increase in orders for DTaP-IPV vaccine (previously distributed as Quadracel®, and now Infanrix®-IPV).

The Infanrix®-IPV supply is limited. Please order DTaP-IPV vaccine only for 5 and 6 year olds who are unimmunized and require doses for their primary series of tetanus, diphtheria, pertussis and polio. Please see Catch-Up Schedule 1 in the Publicly Funded Immunization Schedules for Ontario-March 2015 at www.health.gov.on.ca and search Ontario's Publicly Funded Immunization Schedules.

For the 4-6 year booster dose, use the Tdap-IPV (i.e., Adacel[®]-Polio or Boostrix[®]-Polio). Contact a Vaccine Preventable Disease Nurse if you have questions at 705-743-1000.

Liberia Still on the List for Ebola Virus Disease

On May 9, 2015, the World Health Organization announced that Liberia is Ebola virus disease (EVD)-free after 42 days without any new cases. This is promising and eagerly anticipated news in the fight against this devastating disease - and it demonstrates the progress that continues to be made by government officials, health workers and community leaders in West Africa to manage the response to this epidemic. However, the Ontario Ministry of Health and Long Term Care (MOHLTC) has been in discussion with the federal government to determine whether it would impact the current measures in place in Canada. There are factors, such as the porous borders between Liberia and the other affected countries, which must continue to be taken into account. At this time, the federal government will continue to screen and issue orders to travellers from Liberia under the federal guarantine program. As such, Ontario's measures will remain unchanged until further notice.

Hospitals, paramedic services and primary care settings should continue to consider EVD in patients with recent travel history to Liberia. Health units will continue to monitor travellers from Liberia that are issued orders under the federal quarantine program, and to support any travellers that develop symptoms compatible with EVD to access the health system. The MOHLTC will continue to monitor the situation in West Africa in partnership with colleagues at the federal and provincial levels.

Combating Stigma – For Physicians and Other Health Professionals

The stigma associated with mental illness influences a person's access to, and quality of, care. This new Web-Based Continuing Education (CME) course titled, "*Combating Stigma for Physicians and Other Health Professionals*" is intended to educate family physicians and specialists in the recognition of stigma related to mental illness. The course is designed to help provide participants with an opportunity to recognize attitudes and behaviours that could potentially lead to stigma as well as provide an example of a practical clinical approach to helping doctors, other healthcare professionals, and patients. This course recommends that not only do we need to change the way we think about mental illness, but also how we deliver health services and supports. This approach will address some of the challenges of stigma, especially social distancing, health social contact, and good communication.

Course learning objectives

After completing this course you will be able to:

- 1. Examine your attitudes, beliefs and behaviours toward persons with mental health problems, towards mental health providers, and to the social context and structures of healthcare delivery.
- 2. Identify mental health problems as having biological, psychological, and social aspects to them.
- 3. Describe an organized approach to the treatment of mental health issues using simple practical skills and competencies that work within a busy clinical setting.
- 4. Develop an increased level of comfort and interest in addressing mental health problems and effectively combat the various types of mental health stigma in one's practice and healthcare system.

Organizations interested in participating in Ontario's 2015/16 Universal Influenza Immunization Program (UIIP) are required to complete the annual application process in order to receive and administer publicly funded influenza vaccine. The 2015/16 Universal Influenza Immunization Program (UIIP) application materials are available on the Ontario Ministry of Health and Long Term Care website for both pharmacies and healthcare agencies at *www.health.gov.on.ca/en/pro/programs/ publichealth/flu/uiip/*. Ontario's Autism Parent Resource Kit




