Infectious Disease Update

Pertussis Vaccination Recommendations for Adults and Pregnant Women

With a pertussis outbreak raging in southwest Ontario, and several cases here in Peterborough, we are asking all health care providers to ensure that adult patients are protected against whooping cough as a way to ensure our most vulnerable, newborns and infants, are kept safe.

As of August 2011, the province of Ontario provides a single dose of Adacel to boost adults under 65 years of age who have not previously received it as part of their tetanus immunization. Adacel was introduced as the booster for 14-16 year olds in 2003. Anyone over that age would not have received the vaccine, which protects against tetanus, diphtheria and pertussis. And since pertussis is not mandatory for school attendance, there may be adolescents and young adults that did not get their 14-16 year old booster who would be prime targets for immunization.

Whooping cough in an adult can cause an illness that lasts for months. Without treatment, ill individuals can spread the disease for three weeks. Even when treated with antibiotics, which reduce the ability to transmit the disease, the cough will not improve. Worse though, is that family members and care givers can pass on the pertussis infection to a newborn or infant. This can be life-threatening for the baby.

Although Ontario is not specifically targeting pregnant women and their families, Peterborough's Partners in Pregnancy Clinic (PIPC) is offering the vaccine to all their patients once they have reached 20 weeks gestation. Prospective mothers will protect themselves from passing the infection on to their newborns AND share antibodies, transplacentally and through breast milk, to protect their child until it is 2 months of age and eligible for its first dose of vaccine. PIPC will refer family members of their patients to their family healthcare provider for Adacel vaccination. *The American Advisory Committee on*



Immunization Practices, of the CDC, issued recommendations for immunizing pregnant women with Adacel in 2011. These recommendations can be found on the health unit website at *www.pcchu.ca* in the "For Professionals" section under "*Alerts*".

Pregnancy is a good time to ensure that all household contacts and potential caregivers are immunized against pertussis. In addition, please ensure that your office is equipped with the correct specimen kits to diagnose illness due to pertussis infection.

Nasopharyngeal Specimen Collection for Pertussis

Polymerase Chain Reaction (PCR) testing has optimal sensitivity during the first three weeks of illness when bacterial DNA is still present in the nasopharynx. Sensitivity of the test is highest in the catarrhal stage, before the cough becomes paroxysmal. After the fourth week of cough, the amount of bacterial DNA rapidly diminishes which increases the risk of obtaining falsely-negative results. PCR testing following antibiotic therapy also can result in falsely-negative findings.

Obtain specimen kits from the Public Health Laboratory at 705-743-6811. Remember to check the expiry date before using it. The kit does not have to be refrigerated until after the specimen has been collected. Specimens should be obtained by aspiration or swabbing the posterior nasopharynx. Throat swabs and anterior nasal swabs have unacceptably low rates of DNA recovery and should not be used for pertussis diagnosis.

Universal Influenza Immunization Program (UIIP)

Prequalify by August 24 for the 2012 - 2013 Season

Health care agencies, workplaces and other organizations that want to participate in Ontario's Universal Influenza Immunization Program (UIIP) are required to complete an annual prequalification process to receive publicly-funded influenza vaccine if they plan to store it on their premises.

Please note that physicians who bill OHIP do NOT need to prequalify.

Making the Most of the 18-Month Well-Baby Visit

The 18-Month Well-Baby Visit is a critical time when identification of delays can make all the difference in a child's development, future school success and long term health. It is no longer acceptable to take a "wait and see" approach.

Research continues to show that early interventions and connections to primary care practitioners have a critical role in ensuring that all children meet their developmental potential: physically, emotionally and socially. Parents respect the information they receive from you and will follow your recommendations more than any other health care provider.

The Ontario College of Family Physicians has developed the new best practice, the Enhanced 18-Month Well-Baby Visit. In addition, the province has created a new OHIP billing code for this visit. The fee code for family physicians is A002 and the current billable amount is \$62.20.

Because of the vaccination schedule, the 18-month visit may be the last time you see each child until they start Junior Kindergarten and therefore an important time to complete an enhanced assessment.

In the coming weeks, Leisa Baker, Public Health Nurse will be phoning your office to arrange for a brief visit to explain ways to implement these resources and to provide you with a physician package. The physician package will include a referral flowchart listing local organizations and contact numbers, key assessment screening tools, and resources to give to the parent. If you are interested, children's board books will also be supplied for you to give to the parent to emphasize the importance of reading to their child every day.
