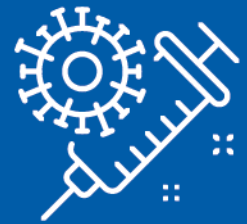

#### COVID-19 Vaccine Status

Peterborough received the first supply of COVID-19 vaccines on January 25. This supply has been used to vaccinate 517 people in long-term care homes (LTCH). The next shipment of COVID-19 vaccine is to be delivered and used the week of February 8. With it, we will immunize the residents of the remaining LTCHs in Peterborough. The Province has a goal of vaccinating all LTCH residents by February 10 and Peterborough is on track to meet this goal. A shipment of Pfizer-BioNTech vaccines are expected to arrive later in February. At this time, a date has not been confirmed.

#### Peterborough Public Health COVID-19 Vaccine Distribution and Implementation Plan

Peterborough Public Health has created a draft high-level plan for the distribution and implementation of the COVID-19 vaccine locally. This document outlines the plan to provide residents with access to the COVID-19 vaccine, ensuring at least 75 percent of eligible Peterborough residents are immunized. Once the plan is finalized it will be shared on the Peterborough Inter-agency Vaccine Planning Team (PIVPT) [webpage](#).

#### COVID-19 Vaccine Sequencing

The Vaccine Sequence Planning Group has proposed a plan for prioritizing populations in phase 1 of the provincial [COVID-19 vaccine distribution plan](#). This plan is being reviewed by the members of PIVPT and will be posted on the PIVPT webpage once finalized.
