### Message from...

There is no question that the last several years have showcased the tireless dedication of Ontario's public health sector to the health and wellbeing of the communities we serve. Locally, Peterborough Public Health entered 2022 with an unwavering commitment to protect and promote the health of the people who call this beautiful region home.

Last year, our commitment to healthy communities occurred on multiple fronts. We continued our ongoing response to COVID-19, investigating 140 local outbreaks and vaccinating over 80% of the local population. We also cast our sights beyond the pandemic by starting to restore critical public health programs and services, which had been paused for nearly 2 years. Finally, we articulated a bold path forward for the organization through our health equity-focused 2022-2025 Strategic Plan.


Despite these forward-looking efforts, 2022 began with arrival of a new COVID variant and the beginning of the pandemic's fifth wave. With that, Peterborough Public Health marked the New Year by rapidly mobilizing to blunt the impact of the fast-spreading Omicron variant. Over a matter of weeks, we stepped up data surveillance and reporting, case and outbreak management, immunization clinics and outreach, and infection prevention and control efforts.

Despite this massive redeployment of our team to the COVID response, a small but mighty team remained behind the scenes to ensure the delivery of crucial programs and services that could not be paused. This skeleton crew worked to reduce barriers to life-saving harm reduction and prevention services, provided vital child health services, maintained public health inspections and investigations, and delivered community services to some of our communities most vulnerable residents.

Despite the immense impact of the pandemic on our staff and community, all of these efforts saved lives. In September 2022, we released new data demonstrating that nearly 300 lives were saved through COVID-related preventative measures embraced by the community. Earlier, in February, we joined with community partners

to celebrate the years-long effort to establish a Consumption and Treatment Services Site in Peterborough and the expansion of local harm reduction services.

The last year has given us multiple opportunities to reflect on our strengths, challenges, and lessons learned. More than ever, 2022 has shown us that public health plays a vital role in maintaining the physical, mental, and social wellbeing of the communities we serve --- and we are incredibly grateful to our community for recognizing the importance of this work.

This report provides a glimpse into some of the achievements of 2022, and highlights the hard work and dedication of our staff in a time of immense community need. Despite the challenges and uncertainty that continues to face public health, Peterborough Public Health staff remain our greatest asset in the work of protecting and promoting the health of the communities we serve.

### 2022-2025 Strategic Plan

### Equity flows through everything we do.

In 2022, we announced the release of our 2022-2025 Strategic Plan, which outlines the priorities to guide the work of our organization and community while sustaining our response to, and recovery from, the COVID-19 pandemic.

The goal of public health is to address underlying determinants of health to prevent disease at a population level. It is through advocacy for social programs, basic needs, and systems change that public health agencies strive to close the gap in equality. Equity flows through all of the work that we do, and we are driven by a commitment to make attainment of health fairer for all.

This strategic plan aims to prioritize the needs of our community members and partners, the well-being of our staff, and the role we play in the healthcare system - using a health equity lens to guide each priority.

### **ORAL HEALTH**

Oral hygiene can lay a strong foundation for lifelong health. In 2022, the Oral Health Team helped to provide a foundation for health in our community by screening over 390 school-aged children in Kindergarten and Grades 2 and 4. In addition, our Community Dental Health Clinic supported healthy smiles by providing 2121 dental care appointments for eligible individuals and families.

### **FAMILY & COMMUNITY HEALTH**

In 2022, the Family and Community Health Team welcomed staff back from COVID redeployment and began refocusing on community needs, strategic plan priorities, and the implementation of local interventions as outlined in the Ontario Public Health Standards. Staff began work to advance strategic priorities related to the prevention of Adverse Childhood Experiences, Climate Change Adaptation, and the local response to the drug poisoning crisis. Staff also ensured the continued delivery of a range of public health services, from nutrition programs focused on increasing food literacy and social connection, to the distribution of naloxone, and collaboration with local schools to improve the well-being of children and youth.

### **CHILD HEALTH SERVICES**

Ensuring the best start possible for local children and families was a key focus underlying the restoration of child health services programming in 2022. This included the completion of over 2700 home visits by staff working within the Healthy Babies, Healthy Children and Infant & Child Development programs. This team also initiated work on Peterborough Public Health's strategic priority to enhance services for underserved single parents and families, with a goal of creating healthy, safe, and nurturing environments for local children.

### **IMMUNIZATION & SEXUAL HEALTH**


Apart from a brief closure to support our COVID-19 Mass Immunization Clinic in early 2022, the Immunization and Sexual Health Team maintained essential services throughout the pandemic. This included diagnosis and treatment of sexually transmitted infections (STIs), and providing contraception and routine immunizations to residents without access to healthcare providers. Program staff also collaborated with other Peterborough Public Health teams to mount a local response to the global Mpox outbreak in February, ensuring cases in our community were supported with testing, case and contact management, and immunization.

### **INFECTIOUS DISEASE**

Effective infection prevention and control measures are central to preventing the spread of disease and ensuring people remain healthy. In 2022, the Infectious Diseases Team leveraged strong community partnerships to protect vulnerable populations from a range of respiratory and enteric illnesses. Together, this team ensured an effective response to over 140 local outbreaks, investigated 215 diseases of public health significance, including 547 cases of influenza, and over 6500 cases of COVID-19 cases. The team also completed over 250 inspections in child care centres, congregate living settings, and personal service settings.


### **ENVIRONMENTAL HEALTH**

In 2022, the Environmental Health Team provided essential inspection services to prevent and mitigate health hazards, and ensure compliance with provincial legislation and the Ontario Public Health Standards. The team mobilized quickly to prevent the spread of avian influenza by supporting local poultry operators with control measures and Personal Protective Equipment (PPE), while providing education and facilitating access to prophylaxis when indicated. Furthermore, the team played a central role in public communication and outreach, offering a vital source of information for municipal partners during the 2022 avian influenza outbreak.




### 2022 Financial Summary
