

COVID-19 Vaccine Appointment Booking Guidance for Pfizer-BioNTech and Moderna

Some people are not able to receive the Pfizer-BioNTech or Moderna COVID-19 vaccine without consulting their healthcare provider. This guidance document can help guide people through the process of consulting their healthcare provider and booking a COVID-19 vaccine appointment.

	<p>People who are Immunocompromised due to disease or treatment and are receiving the following treatments:</p> <ul style="list-style-type: none"> Stem cell therapy CAR-T therapy Chemotherapy Immune checkpoint inhibitors Monoclonal antibodies (e.g. rituximab) Other targeted agents (e.g. CD4/6 inhibitors, PARP inhibitors, etc) 	<p>Patients who are Immunocompromised due to disease or treatment and are NOT receiving the following treatments:</p> <ul style="list-style-type: none"> Stem cell therapy CAR-T therapy Chemotherapy Immune checkpoint inhibitors Monoclonal antibodies (e.g. rituximab) Other targeted agents (e.g. CD4/6 inhibitors, PARP inhibitors, etc) 	<p>Patients who have had severe allergic reactions or anaphylaxis to a previous dose of a COVID-19 mRNA vaccine or to any of its components should NOT receive the mRNA COVID-19 vaccine in a general vaccine clinic.</p> <p>The components of the vaccine include:</p> <ul style="list-style-type: none"> Polyethylene glycol due to possible cross-reactivity, polysorbate <p>OR</p> <p>Patients who have had an allergic reaction within 4 hours of receiving a previous dose of an mRNA COVID-19 vaccine or any components of the vaccine (such as hives, swelling, or wheezing).</p>	<p>Patients who have had an allergic reaction within 4 hours and/ or anaphylaxis that occurred with a vaccine or other injectable medication that does not contain a component or cross component of the mRNA COVID-19 vaccine</p> <p>OR</p> <p>Patients with a history of significant allergic reactions and/or anaphylaxis to any food, drug, venom, latex or other allergens not related to the mRNA COVID-19 vaccine</p> <p>OR</p> <p>Patients with allergy issues like allergic rhinitis, asthma and eczema</p>	<p>People who are pregnant</p>	<p>People who are breastfeeding</p>
